### CALLS FOR PROPOSALS

In 2016, we selected proposals through two calls, supporting 35 projects in the whole country. The amounts donated reached R\$ 677,250.00. This year, the highlight was the opportunity to support projects to support youth in their fight against state violence, which allowed Brazil Fund to go deeper into a very relevant theme, which became

a priority in the present historical moment in Brazil. We also provided emergency funding to four projects. In this report, we covered projects selected in previous years, through calls for proposals and invitation letters that in 2016 received funding to continue the projects.

### ANNUAL CALL "FIGHT AGAINST INSTITUTIONAL VIOLENCE AND DISCRIMINATION"

Twenty projects were chosen through a broad and transparent selection process. These proposals were divided into several different themes related to the defense of rights.

We count on a selection committee formed by Beth Cardoso, coordinator of the Women and Agroecology in Network Program of the Zona da Mata Center for Alternative Technologies; Cleia Silveira, Coordinator of the Saap Fund; Letícia Tura, Executive Director of Fase; Miguel Lago, of the My River network; Mônica Oliveira, Consultant and former Director of Programs at Seppir (Secretariat for Affirmative Action Policies); Paulo Pankararu, Indigenous lawyer; And Samira Bueno, Executive Director of the Brazilian Forum of Public Security.

### PROJECTS SUPPORTED

### AACE - ANTINUCLEAR ARTICULATION OF CEARÁ

**OBJECTIVE:** Make sure that the peasant populations directly affected by nuclear energy production and fertilizers are able to preserve their traditional ways of life and work, and their sustainable development in Ceará.

**ACTIONS:** Through an advocacy campaign, make visible and focus the socio-environmental impacts caused by the production of nuclear energy and fertilizers in the central hinterland region of Ceará.

**MAIN THEMES:** Environmental rights within mega-projects.

### SPORTS AND CULTURAL CAPOEIRA ASSOCIATION MESTRE BIMBA

**OBJECTIVE:** To preserve and protect Afro-Brazilian religious temples in the metropolitan area of Goiânia, focusing on the cities of Goiânia and Aparecida de Goiânia..

**ACTIONS:** Seminar; free legal advice to Afro-Brazilian religion temples seeking regularization; Monthly meetings of articulation of the Forum of Religions of African Origin of Goiás; a Carnaval group; Afonso Oju Odê Walk.

MAIN THEMES: Confronting racism.

### TRANSVESTITES, TRANSSEXUALS AND TRANSGENDER ASSOCIATION OF GOIÁS

**OBJECTIVE:** Elaborate and produce a reference guide to subsidize the creation of a culture of prevention of human trafficking, with information on the theme and ways to identify and act against this type of crime.

**ACTIONS:** Establish a dialogue with governmental and non-governmental actors at the federal, state and municipal levels; promote workshops to elaborate information material; produce and disseminate this material; meetings and visits to the places where these public services are offered.

**MAIN THEMES:** Right to free sexual orientation and gender identity.

### **SEVEN COLORS LGBT ASSOCIATION**

**OBJECTIVE:** Contribuir para a formação política de jovens LGBT moradores das regiões da Mata, Agreste e Sertão Pernambucano para o enfrentamento às diversas formas de preconceito e discriminação, além da sensibilização de gestores municipais.

**ACTIONS:** Training and planning meetings of the LGBT network of the countryside cities of the State of Pernambuco; meetings with public authorities; training course for LGBT leaders; evaluation meeting.

**MAIN THEMES:** Right to free sexual orientation and gender identity.

### SINGLE MOTHERS ASSOCIATION OF PERNAMBUCO

**OBJECTIVE:** Ensure the acknowledgement of paternity to at least a thousand children, through the establishment of interactions between women, wives, partners, prisoners and ex-wives of prisoners strengthening their affective and family bonds.

**ACTIONS:** Distribution of flyers to the families of detainees with information about the project; awareness raising debates, lectures and seminars; elaboration of graphic material; meetings with public authorities; dissemination of information and debates on legislation; periodic visits to prisons, distribution of flyers and meetings with partners and prison authorities; identification of document status to request authorities for the acknowledgement of paternity; evaluation interview; exposure in the press; seminars; collective work and petitions.

MAIN THEMES: Women's Rights.

### QUILOMBOLA ASSOCIATION MAROBA DOS TEIXEIRA

**OBJECTIVE:** To foster maroon people's territorial articulation, by pressing for land regularization and fighting social inequality, in addition to strengthening each specific struggle of the maroon communities.

**ACTIONS:** Planning meetings, organization and preparation of activities; socialization meetings, systematization and further development of the main issues; elaboration and strategy meeting; workshops; solidarity actions; public action in favor of land regularization and titling of maroon territories.

**MAIN THEMES:** : Rights of Maroons and Traditional Peoples

### CAMPESTRE FM COMMUNITY RADIO ASSOCIATION

**OBJECTIVE:** Promote and discuss the issue of violence against women in the city of Campestre, Alagoas, through the dissemination of information, training and reporting of cases occurred in the city.

**ACTIONS:** Radio, photography and free media communication workshops; training session on human rights with emphasis on women's rights; production of a radio show with women centered themes, such as women's health and rights; campaign on violence against women; dissemination of educational, training and informational material on the rights of women; lectures in schools; a seminar.

MAIN THEMES: Women's Rights.

### ASSOCIATION OF WOMEN PRODUCERS OF PAJEÚ

**OBJECTIVE:** Empower women from this region to build strategies that allow tackling the various forms of violence experienced in women's everyday life, especially gender and institutional violence.

**ACTIONS:** Seminar; trainings with leaders; workshops to disseminate the knowledge acquired in the training; newsletters; application of questionnaires identifying organizations that support and protect women victims of violence.

MAIN THEMES: Women's Rights.



### BAMIDELÊ - WOMEN ORGANIZATION IN PARAÍBA

**OBJECTIVE:** Contribute to the implementation of Law 10.639 / 03, which determines the teaching of Afro-Brazilian and African history and culture emphasizes the importance of the Black culture in the education of Brazilian society and consider it as an instrument to confront racism, developing a process of awareness raising in the schools, community and in society.

**ACTIONS:** Training activities with teachers; story telling; educational activities; the event Saberes Negros Fair; interventions in social media; process and dissemination of successful law enforcement experiences.

MAIN THEMES: Confronting racism.

### YVES DE ROUSSAN CENTER FOR THE DEFENSE OF CHILDREN AND ADOLESCENTS - CEDECA

**OBJECTIVE:** To sensitize and provide tools for teachers and students to prevent sexual violence so that they can identify, denounce and direct cases to the safety network.

**ACTIONS:** Preparation of pedagogic and informative material; provide trainings for the school's professionals; workshops with students of those institutions; elaboration of a report as a final product of the activities carried out; event to present the results.

**MAIN THEMES:** Rights of children and adolescents.

### GROUP OF WOMEN FAMILY MEMBERS OF ADOLESCENTS IN JUVENILE DETENTION UNITS

**OBJECTIVE:** Strengthen women's autonomy in the struggle to defend their rights and those of the adolescents in juvenile detention units in the state of Ceará through political education, community mobilization and the establishment of communication channels to report the violations they suffer on a daily basis.

**ACTIONS:** Promotion of the work performed by the group of women family members of adolescents in juvenile detention units; series of local meetings; exchange meetings to integrate the participant women to integrate them and share experiences on ways to resist the violations of rights; integrate agendas with the feminist movement.

**MAIN THEMES:** Rights of children and adolescents.

### TRANSAS DO CORPO GROUP -EDUCATIONAL ACTIVITIES ON GENDER, HEALTH AND SEXUALITY

**OBJECTIVE:** To build spaces for dialogue and exchange of experiences between youth and adults in public schools in Goiás on the types of existing violence and human rights advances on the issue.

**ACTIONS:** Integrated arts following the pedagogy implemented by the Theater of the oppressed; exhibition of videos produced by women working against gender violence; production and presentation of a news-theater show aiming at critically analyzing the role of media.

**MAIN THEMES:** Right to freedom of expression, organization and manifestation.

### Madeira Vivo Institute - IMV

**OBJECTIVE:** The main objective is to denounce the violation of human rights due to the implementation of the hydroelectric complex on the Madeira River, in Rondônia.

**ACTIONS:** Obtain from Caiari Radio, of Porto Velho, a 90 minutes slot to execute the show Vozes da Amazônia; Strengthen the Network of Entities in Defense of Life; using free legal advice services prepare and file in court a lawsuit for the compensation of the flooded communities; organize a seminar; produce information material.

**MAIN THEMES:** Environmental rights within mega-projects.

### IZAQUE JOÃO (INDIVIDUAL PROJECT)

**OBJECTIVE:** Disclose and denounce human rights violations against practitioners of traditional Guarani-Kaiowá religiosity, our Nhanderu and Nhandesy (shamans, or chanters) and their followers.

**ACTIONS:** Visits to communities of indigenous people in Mato Grosso do Sul to collect testimonies on the cases; event to bring together the Nhanderu and Nhandesy and formulate proposals to be presented to public authorities; dissemination of information on social media on a website/blog; summarizing of information.

MAIN THEMES: Rights of Indigenous Peoples.

### MOTHERS OF MAY INDEPENDENT MOVEMENT

**OBJECTIVE:** Raise awareness and promote historical and aesthetic elaboration to ensure the right to memory, truth, justice, reparation and peace in the city of São Paulo.

**ACTIONS:** Capacity building activities with poetic, hip-hop and audiovisual interventions on the 10th anniversary of the May Crimes; Convergence of photographic, plastic and literature material produced during the activities; compilation and publication of the book "10 Years of the May Crimes - The Funeral March Continues".

**MAIN THEMES:** Guaranteeing the rule of law and criminal justice.

### COLLECTIVE WORK FOR CITIZENSHIP/ XINGU VIVO MOVEMENT

**OBJECTIVE:** Encourage and support the resistance played by the population threatened by the mining company Belo Sun through the promotion of capacity training, information, social mobilization and articulation of the authorities related to the Judiciary power in Pará.

**ACTIONS:** Visits to the islands where communities are threatened by the mining company; organization of meeting with these communities; meeting with public authorities in Altamira; capacity building meetings with communities on the Xingu islands.

MAIN THEMES: Environmental rights within mega-projects.

### Friends of the Earth Brazil (ATBr)

**OBJECTIVE:** Resist, promote people's empowerment, and report rights violations in three territories in the southern region of Brazil, in urban and rural areas, in a context of nature financialization.

**ACTIONS:** Capacity building on privatization, commodification and financialisation of nature, common goods and public spaces; experience exchange and reports of violations of rights; production of audiovisual and printed material; production and launch of dossier on this issue; monitoring and production of information.

**MAIN THEMES:** Environmental rights within mega-projects.

### INDIGENOUS ORGANIZATION OF THE KAYAPÓ DO BAÚ - OIB

**OBJECTIVE:** Fight mining activities inside and outside indigenous lands through the mobilization of Kayapó leaders and communities of the Indigenous land of Baú and Mekrangnotire.

**ACTIONS:** Research on the main mining areas; demand rights from public authorities; organize meeting with indigenous leaders to dialogue and define strategies; occupation of mineral exploration areas; demonstrations; awareness raising.

MAIN THEMES: Rights of Indigenous Peoples.

### NETWORK OF COMMUNITIES AND MOVEMENTS AGAINST VIOLENCE

**OBJECTIVE:** To strengthen the work carried out by relatives of victims of institutional violence in the state of Rio de Janeiro in the struggle for justice and against state violence in the favelas.

**ACTIONS:** Psychological assistance for relatives of victims of institutional violence; follow-up with the families involved in the most recent cases; gatherings to promote solidarity and experience exchange; collective elaboration of an activities schedule; public hearing.

**MAIN THEMES:** Guaranteeing the rule of law and criminal justice.


### OMOLAYE SOCIETY OF ETHNIC, POLITICAL, SOCIAL AND CULTURAL STUDIES

**OBJECTIVE:** Provide legal and communication assistance to the religious people and to the Afro-Brazilian temples in Sergipe that suffer institutional racism.

ACTIONS: Prepare and supervise judicial and administrative processes; mobilization and collective construction of strategies; organization of a council composed of older religious women; capacity building and training workshops; communication strategies; seminar.

MAIN THEMES: Confronting racism.

### CALL FOR PROPOSALS "UNITED AGAINST THE VIOLENCE THAT KILLS THE BRAZILIAN YOUTH"

Support 15 projects distributed in ten Brazilian states focused on facing the violence that affects youth, especially the Black youth. The call sought to strengthen the proactivity of young people in the struggles for their rights and was launched in the form of a comic book, seeking to dialogue with this audience. The projects were analyzed by a selection committee formed by the lawyer Valdênia Paulino, from the Human Rights Defense Center of Sapopemba, in São Paulo; by the journalist Itamar Silva of Ibase (Brazilian Institute of Social and Economic Analysis), in Rio de Janeiro; And economist José Carlos Zanetti, from Cese, in Bahia.



### CDDH MARÇAL DE SOUZA TUPÃ-I

**OBJECTIVE:** To promote the importance of protecting the dignity and human rights of adolescents in conflict with the law in Campo Grande (MS).

**ACTIONS:** Thematic workshops; discussions; seminars; reporting and addressing of complaints; partners articulation; visits to juvenile detention units to assist the adolescents.

### CARMEN BASCARÁN CENTER FOR THE DEFENSE OF LIFE AND HUMAN RIGHTS - CDVCH / CB - MARANHÃO

**OBJECTIVE:** Contribute to the fight against violations of fundamental rights, violence and social exclusion of young people in situation of social vulnerability in Maranhão by means of producing art and culture as a strategy to encourage the proactivity and social participation of youth.

**ACTIONS:** Offer capacity training courses for socio-cultural educators on human rights themes and on the art of African dance; Capacity training courses for socio-cultural educators in human rights on the art of capoeira; Mobilization and social awareness events; speeches; walking; seminars.

### CENTER FOR DEFENSE OF HUMAN RIGHTS - CDH PETRÓPOLIS

**OBJECTIVE:** To conduct a researchintervention to investigate the number of teenagers arrested in Petrópolis, identifying whether the arrests were related to drugs and the type of sentences they received for the committed offences. The research aims to discuss the position taken by judges on the Statute of the Child and Adolescent (ECA), considering the issue in a profound way from the experiences and denunciations received and the reading of the bibliography raised. Interventions to assist the adolescents will also be carried out.

**ACTIONS:** To draw the profile of the adolescents who are in juvenile detention units; systematize reports of mistreatment; seminars; assist the adolescents in the units; meetings; organization of group meetings with those adolescents who have already been in the units.

### NATIONAL INDIGENOUS YOUTH COMMISSION - CNJI - NORTH EAST REGION

**OBJECTIVE:** Mobilize and empower the indigenous youth in Ceara on the violations of indigenous rights in the present days.

**ACTIONS:** Regional and state workshops; Visits to indigenous communities.

### COMMITTEE OF THE STATE OF CEARÁ FOR THE DEMILITARIZATION OF POLITICS AND OF THE POLICE

**OBJECTIVE:** Promote dialogue with people living in areas where the military is most lethal and where it most violates rights.

**ACTIONS:** Series of workshops; seminars, hearings and meetings; preparation of dossier and booklet; articulation with youth movements; cultural events.

### **OJU IFÀ COMMUNITY**

**OBJECTIVE:** To form a working group through the mobilization of young people to identify institutional and lethal violence victims in Sergipe, as well as to point to the spectacularization of vulnerabilities and moral offenses directed to the honor and to the image, and also the state inertia.

**ACTIONS:** Mobilization of youth; consolidation of the working group; legal advice; seminar celebrating the launch of the project.

### CONEXAO LGBT CITIZENSHIP GROUP FOR SLUM DWELLERS

**OBJECTIVE:** Creation of the itinerant group "Nice to Meet You, I exist", to provide assistance and guidance to the people who are victims of prejudice and discrimination based on sexual orientation and gender identity in Rio de Janeiro.

**ACTIONS:** Articulation with the community leaderships of other slums; assistance; creating of electronic application to be used as a denouncing tool for the LGBT population of slums.

### GRUPO OUSADIA JUVENIL (DARING YOUTH GROUP)

**OBJECTIVE:** Reflect upon the reality experienced by Black youth in low income communities in the east of Mossoro, Rio Grande do Norte, highlighting the lack of specific public policies for youth.

**ACTIONS:** Lectures on public policies and on the extermination of Black youth; debates; gatherings; a seminar; a documentary and a festival.

### PEOPLE's UNIVERSITY INSTITUTE - UNIPOP

**OBJECTIVE:** Enabling the creation of a news agency that fights the extermination of young people, especially poor and Black youth.

**ACTIONS:** Capacity training workshops; mapping of initiatives in the peripheral communities of Belém to produce content and disseminate it on social media; mobilization; monitoring; public hearing in the Legislative Assembly.

### LEVANTE POPULAR DA JUVENTUDE (Youth Uprising)

**OBJECTIVE:** Contribute to set the issue of Black youth extermination in the public agenda as a social problem, as well as in the political agenda of public authorities.

**ACTIONS:** Organize groups of young multipliers; articulate a network in five Brazilian states; development of mobile phone app; database; capacity training for students from public schools.

## MOVIMENTO HIP HOP ORGANIZADO

### (MH20) E TURMA SÃO BENTO

**OBJECTIVE:** To value the historical experiences of the national hip-hop movement that were aimed at the prevention and resistance to violence, above all the institutional and police violence used against the Black and poor youth living in the outskirts of big cities.

**ACTIONS:** Hip-Hop meetings at the São Bento Metro Station; a large meeting at the end of the year; implementation and launch of an on-line memorial; elaboration of training material, both printed and on video.

### LEGAL ASSISTANCE CENTER FOR THE PEOPLE - NAJUP

**OBJECTIVE:** Promote legal and political training for the youth of the Terena indigenous people living in Mato Grosso do Sul on their rights as citizens, raising awareness to their rights as indigenous people.

**ACTIONS:** Training workshops; youth meetings with indigenous leaders (caciques); research on the indigenous youth.

#### **ODARA BLACK WOMEN'S INSTITUTE**

**OBJECTIVE:** Raise awareness of five communities in the outskirts of Salvador about the harm and impacts caused by police violence and drug trafficking in the lives of adolescents, young Black men and their families.

**ACTIONS:** Advocacy actions; public hearing; seminars; strengthening of solidarity and protection network actions; workshops;

### RAPROATIVO


**OBJECTIVE:** Raise critical awareness of the children and adolescents living in Pirituba, in the outskirts of São Paulo, about their rights, denouncing the violence in the outskirts of big cities and the omission in the institutional fulfillment of these rights.

**ACTIONS:** Publicizing of actions and formation of partnership with other organizations; occupation of public spaces; gathering of information in a portfolio that will serve to organize other occupations.

### REVISTA AFIRMATIVA (AFFIRMATIVE MAGAZINE)

**OBJECTIVE:** Make a public call for young communicators to produce a video series and a printed magazine about youth violence.

**ACTIONS:** Public call for the production of videos; election of a team of curators; creation of a YouTube channel; free media training course; rehearsal contest; free distribution of half of the of the printed version of the magazine in university preparatory courses and Black youth groups in the state of Bahia; elaboration of a series of stories to be broadcasted on the web, at the Affirmative Portal.

### CALL FOR PROPOSALS FIGHTING HUMAN TRAFFICKING

Launched in 2015, this call was made to groups fighting human trafficking. Eight organizations were supported that year. In 2016, the actions carried out through this announcement were systematized in a publication that seeks to record the processes, results and learning of Brazil Fund through the actions held.





### CALL FOR PROPOSAL STRATEGIC LITIGATION



The publication "Strategic Litigation in Human Rights - Experiences and Reflections" presents the results of the projects developed thanks to the specific call launched in 2014. The call for "Strategic litigation, advocacy and communication for the promotion, protection and defense of human rights" was held in partnership with Ford Foundation.

The articles on the publication show eleven emblematic cases in which actions aimed at the Judiciary power and government sectors made possible the transformation of situations involving the violations of rights. The articles were written by the groups themselves and edited by Brazil Fund.

In addition to the cases, the publication provides reflections through interviews with specialists in the subject.

An overview of the Strategic Litigation and Human Rights Conference held in April 2016 was also organized.

### FOUNDATION RECEIVES MENÇÃO HONORABLE MENTION AT THE INNOVARE AWARD

The honorable mention in the Justice and Citizenship category of the Innovare Award was an important achievement in the 10th anniversary of Brazil Fund.

The honorable mention in the 13th edition of this award was granted to the call "Strategic litigation, advocacy and communication for the promotion, protection and defense of human rights" held in partnership with the Ford Foundation.

Four hundred and eighty-two projects were enrolled in this category and only two reached the final round.

The Innovare Award is the most important award involving Brazilian Justice and seeks to honor initiatives in the search for solutions to the challenges faced by all those who work in the justice system, whether in the administrative or judicial fields.



### SPECIAL FUNDING LINE **CRIMINAL JUSTICE**

### PRE-TRIAL DETENTION IN RIO DE JANEIRO AND SÃO PAULO

This special funding line is a partnership between Brazil Fund and OAK Foundation. The supported projects have fought the human rights violations faced by incarcerated people in pre-trial detention regime.

In 2016, Brazil Fund followed the development of their activities and provided part of the expected funding for the six projects financed by this special funding line in Rio de Janeiro and São Paulo.


### PROJECTS **SUPPORTED**

Institute of Religion Studies - Iser (Rio de Janeiro) Institute for Defense of the Right to Defense - IDDD (São Paulo) National Prison Pastoral (São Paulo) Criminal Justice (Rio de Janeiro)



All initiatives were chosen in 2014 and received invitation letters. This support made possible the strengthening of organizations working to implement and transform public policies.

The groups developed activities regarding the documentation and monitoring of activities; they carried out campaigns; advocacy and litigation; technical advice and applied research.



### PRE-TRIAL DETENTION IN THE NORTHEAST OF BRAZIL WITH A FOCUS ON RACIAL ISSUES

This initiative stems from the partnership formed between Brazil Fund and Open Society Foundation, which for the first time made it possible to support initiatives that address human rights violations in pre-trial detention regime prisons, with a specific focus on racism in the Northeast region. Racism is a structuring element in Brazilian society and manifests itself in all social relations in the country, including in the prison system.

The four supported organizations were selected by means of an invitation letter. The projects were analyzed by specialists in the theme.



### PROJECTS SUPPORTED

### LEGAL ASSISTANCE OFFICE FOR GRASSROOTS ORGANIZATIONS

**OBJECTIVE:** To support the rights of people in pre-trial detention in Pernambuco in their fight against the abusive and illegal use of pre-trial detention, with a focus on racism. **ACTIONS:** Debates with police instructors on racism; capacity building meetings; meetings with the Public Prosecutor, the Judiciary power and the Public Defender; data collection at custody hearings; qualitative interviews with provisional prisoners; a publicity campaign on the theme; a seminar and an evaluation of the campaign.

### INEGRA – BLACK WOMEN'S INSTITUTE OF CEARÁ

**OBJECTIVE:** The project will focus on public policies, so that incarcerated Black women in Ceará can have fast access to justice ensuring their rights and reducing the number of pre-trial detainees.

**ACTIONS:** Organize meetings with networks and social movements; working group to search for alternatives; seminars, public hearings, lectures and monitoring visits; assist women serving alternative sentences; a communication campaign.

### **IDEAS - POPULAR ADVISORY**

**OBJECTIVE:** Support the fight against criminalization, mass incarceration and the genocide of Black people, working to reduce the incidence of detentions and the number of prisoners in precautionary and pre-trial detentions resulting from crimes related to trafficking, robbery and theft of small amounts.

**ACTIONS:** Requesting data from public organs of the criminal enforcement system; offering legal education; strategic litigation; research on the modus operandi of the organs of the penitentiary system and collection of data on the profile of the prison population; publication of research data; debate. ### SOCIEDADE MARANHENDE DE Human RIGHTS SOCIETY OF MARANHÃO (SMDH)

**OBJECTIVE:** Evaluate the implementation and effectiveness of custody hearings for the reduction of pre-trial detention in the Northeast of Brazil, with a view to raising awareness to the level of selective violence employed by the justice system, which relates to social class, race/color and territory.

**ACTIONS:** Visits to prison's screening units; interviews with temporary detainees and their families; monitoring of custody hearings; reporting on the visits; systematization of data and analysis of the status of provisional prisoners in custody hearings; meetings with the public organs related to the issue; publicizing the project.





### EMERGENCY FUND

**EXAMPLES OF EMERGENCY SUPPORT OFFERED IN 2016** 

### CENTER FOR THE DEFENSE OF CHILDREN AND ADOLESCENTS OF CEARÁ - CEDECA

The emergency support provided by Brazil Fund made possible the participation of Cedeca - Ceará in the Inter-American Commission on Human Rights of the OAS / IACHR (Organization of American States) session, held last December, in Panama.

In 2015, together with Anced (National Association of Child and Adolescent Defense Centers) and the DCA Forum (Permanent NGO Forum for the Defense of the Rights of the Child and


and the adolescent), Cedeca Ceará filed a petition at the Inter-American Commission on Human Rights of the OAS / IACHR denouncing violations in the socio-educational system of Ceará against the rights of adolescents deprived of their freedom.

The session was an important opportunity to update the details of the case to the Commission, with the ultimate goal of ending the violations in Ceará.

### **TONICO BENITES**

The emergency support granted to Tonico Benites, an indigenous Guarani-Kaiowá, made possible the participation of indigenous leaders in an "Aty Guasu emergencial" held between December 16 to 18 with the participation of an European Parliament commission during its visit to Mato Grosso do Sul.

Aty Guasu is a large assembly of the Guarani-Kaiowá people. The Guarani-Kaiowa have organized these assemblies since the late 1970s, with the objective of supporting the resistance to land eviction and to recover the land from which dozens of communities were evicted throughout the 20th century.



# **STRENGTHENING CAPACITIES**

In 2016, in addition to offering financial support, Brazil Fund sought to strengthen its partners through activities such as capacity building workshops for human rights defenders, discussions, conferences and seminars.

For the first time in the Fund's history, we also carried out exchange activities among the supported organizations as a way to promote closer contact between human rights defenders who work on the same themes in different regions of the country.

The exchange of experiences and the strengthening of organizations are some of the positive consequences of these exchanges, something that differentiates Brazil Fund in a scenario of setbacks in the area of human rights with the increasing need to resist the challenges imposed.

The Fund also carries out monitoring visits, through which it offers technical and strategic assistance and has the opportunity to watch from close the reality faced by the supported groups.

In addition, the projects are continuously monitored by the Brazil Fund team.

### STRATEGIC LITIGATION IN HUMAN RIGHTS CONFERENCE

In April, Brazil Fund held a conference on "Strategic Litigation in Human Rights" in partnership with Ford Foundation at Getulio Vargas Foundation Law School's auditorium, in São Paulo. In addition to the conference, the representatives of the supported projects on this theme participated in discussion panels and exchanged experiences.

The main theme of the conference and the discussion panels was the strengthening of actions related to emblematic cases that could influence state action, the review or implementation of public policies and the improvement of legislation.

The invited debaters were Eloísa Machado, a professor at the Strategic Litigation Clinic at FGV Direito SP; Celeste Melão, coordinator of the Model Office and professor at the Faculty of Law of PUC-SP; Daniel Sarmento, lawyer and professor of law at UERJ; Darci Frigo, coordinator of the Land Rights and Platform Dhesca (Paraná); Kenarik Boujikian, Judge of the Court of Justice of São Paulo, member of the Judges for Democracy Association and advisor to the Brazil Fund; And Nívia Monica da Silva, Justice promoter, member of the Public Ministry of Minas Gerais and coordinator of the Human Rights CAO in Minas Gerais.

### PROJECTS MEETINGS

Representatives from 35 projects supported by Brazil Fund gathered in São Paulo from December 5 to 9 to participate in formative and capacity building activities on youth and political action; youth and violence; technologies and the need for digital security; visibility and communication.

In 2016, the Projects Meeting brought together two different groups: project representatives supported through the 2016 annual call for proposals and representatives of the projects supported by the specific call for proposals "United against the violence that kills Brazilian youth".

In the debates, issues such as the use of the available technologies were addressed; making the cause visible as a way to strengthen the performance of groups and collectives; the lack of space for social themes in traditional media vehicles; and the strategies to escape the official narrative adopted by the hegemonic press

Through the activities proposed by the Brazil Fund team, the participants had the opportunity to report on the stories of their groups, the difficulties they faced, the actions that were taken and the partnerships they formed. During these activities, the groups presented their communication strategies, exchanged ideas and discussed the techniques that can be used in the daily routine of human rights defenders.


### RECIFE

Between the end of June and the beginning of July, organizations working in the Criminal Justice special funding line, gathered in Recife (PE) to discuss the experience with custody hearings and the influential role organizations working on the topic of Criminal Justice play; the problematization of racial issues with a focus on institutional racism; presentation of projects developed with the support of Brazil Fund and dialogue on common issues, difficulties and prospects regarding the excess of temporary incarceration.

the exchange promoted by Brazil Fund also included a conversation with the Pina community in Recife about selective police approach and the massive incarceration of Black young men, and a visit to the Derby headquarters to meet the Working Group on Racism in the Military Police.

### VISITS

### IN MINAS GERAIS, GROUPS SUPPORTED BY BRAZIL FUND FIGHT MEGAPROJECTS

The monitoring trip held in June to traditional communities in Minas Gerais and Mariana region resulted in the publication of a series of materials on Brazil Fund's site and social media on the activities held by local organizations supported by the foundation to defend the land and fight megaprojects in the region, such the mining projects.

The visits were carried out by the project coordinator of Brazil Fund, Taciana Gouveia, and the communication advisor Cristina Camargo. Among the stories shared in the visit, there was one of a couple that has been fighting the mining company in Brumadinho and struggles to keep their land bought with family savings.

Another tragic story shared among the participants was of a former resident of Bento Rodrigues, the district of Mariana that was destroyed by the mud of the mining company Samarco after the rupture of the Fundão dam.

In the Northern region of Minas Gerais, small farmers resist in the Vale das Cancelas against the territorial expropriation promoted by large monoculture plantations of eucalyptus and by mining companies that have been advancing through the region of Grão Mogol and Alto Rio Pardo de Minas.

### IN RIBEIRÃO PRETO, A COMMUNITY WINS LAW SUIT

NAJURP (Center for Legal Assistance of Ribeirão Preto), another project supported by Brazil Fund, offers legal assistance to residents at risk of losing their homes. In April 2016, the Fund and the project's participants visited one of the supported communities and held a discussion with community leaders.

With the assistance of Najurp, the residents of the João Pessoa and Nazaré Paulista communities won, in 2016, the repossession suit that threatened them.

The work was performed through a partnership held with the Public Defender's Office.

# MOBILIZATION FOR HUMAN RIGHTS

Although the number of individual donors is still far from what would be required to guarantee a sustainable support to NGOs working with human rights, in 2016, Brazil Fund has made progress in what concerns the creation of strategies to attract people's attention to the importance of human rights and concerning this debate with the different segments of society.

Fundraising and the development of a local environment that supports the defense of human rights are actions that are part of the Fund's strategy.

In 2016, Brazil Fund carried out a series of activities in the field of communication with the aim of broadening the human rights mobilization in the country.

### CAMPAIGNS



## #NÃOTÁTRANQUILONÃOTÁFAVORÁVEL

A second campaign was launched in August and used as a motto the chorus of a popular song in Brazil and through that, it caught the attention of social media.

The digital media was used to provide visibility to the mobilization and to obtain the support of people in every region of the country.

The campaign counted on the participation of many celebrities who sent photos holding signs with different hashtag phrases related to the themes supported by Brazil Fund. Artists, activists, youtubers and athletes joined the mobilization. Some of the most acnowledged ones were the activist Maria da Penha, the singer and composer Lenine, the singers Leci Brandão and Fabiana Cozza, the actress and one of the Fund's advisor Letícia Sabatella, and the former consulate Alexandra Loras.

In addition, the general public could also participate by sending photos in support of human rights causes. Those people interested in participating could go the campaign's hotsite where they would find messages with hashtags created especially for the mobilization. More than 200 photos were posted.

The campaign was structured around a Youtube channel, an Instagram profile, a Gmail account to send marketing emails, two street actions, posts and ads on social media in general, and on Facebook.

Two street actions also mobilized dozens of people at Paulista Avenue and showed that human rights causes have the potential to gather support.

People passing by at Paulista ave. were invited to pose for picures holding signs related to the themes of the campaign. The images were published on a website specially created for the mobilization.

### SAY YES TO HUMAN **RIGHTS IN BRAZIL**

Held between the months of May and July, the campaign "Say yes to human rights in Brazil" was supported by the actress Jessica Ellen on Facebook posts.

### CHANGE

Another action related to the mobilization for human rights was the sponsored campaign created in the international platform Change. Org, a website that organizes online petitions connected to various causes. Brazil Fund collected signatures of people who were favorable to human rights so that they could be contated in the future.

## NOTA FISCAL PAULISTA PROGRAM

The mobilization through the Nota Fiscal Paulista program continued in 2016. The program works by offering credit to the consumers who ask for the bill of sale when they buy goods. This credit is then donated to Brazil Fund to support the work carried out by the foundation.

In order to engage shop owners, in 2016, four campaigns were held in March, June, September and December, around commercial themes

### PARTICIPATION IN THE PHILANTHROPY FOR SOCIAL JUSTICE NETWORK



Brazil Fund is one of the members of the Philanthropy

for Social Justice Network, an organization that brings together funds that work to promote a new type of philanthropy in Brazil.

As an active member of the Philanthropy Network, the Fund took part in various forums, debates and publications in Brazil and abroad.

The Philanthropy for Social Justice Network was created in 2012 bringing together a group of organizations in the field of philanthropy with similar values and lines of action to direct their actions to the strengthening of human rights, equality and social justice.

#### Interview for the Mobiliza website

Created with the goal of connecting good ideas with resources to materialize them, the Mobiliza website published in September a story about the fundraising challenges faced by independent funds.

The executive director of Brazil Fund, Ana Valéria Araújo, was one of the people interviewed.

She spoke about the difficulties in attracting resources and carrying out mobilization campaigns to raise awareness of the population on the true meaning of human rights and the importance of the work performed by civil society organizations.

### AWID FORUM

### PUBLICATION OF WGPSJP

The partnership between Brazil Fund and the Mothers of May Movement was one of the stories told on the publication **"Effective Philanthropy"**, published by the Working Group on Philanthropy for Social Justice and Peace, which counted on the participation of Ana Valéria Araújo in its management team.

The publication was released in May, with stories about organizations that support social transformation to make systemic changes around the world.

### **IHRFG CONFERENCE**

From July 12 to 14, Brazil Fund participated in the International Human Rights Funders Group Conference held at the New York University School of Law.

The theme of the conference was "Ceasing opportunities: supporting the human rights movement" and one of the panels was organized by the Philanthropy Social Justice network. Alongside Andrés Thompson, coordinator of the network, and KK Verdade, of Fundo Elas, Ana Valéria Araújo, executive director of Brazil Fund spoke about the Brazilian context, approaching the political crisis and the setbacks in human rights in the country.

In 2016, the coordinator of the Brazil Fund was a member of the IHRFG steering committee.

# STRATEGIC COMMUNICATION

### A BRAZIL OF RIGHTS

Ten people were invited to collaborate and they shared remarkable stories from the first decade of Brazil Fund in the magazine "A Brazil of Rights", edited by Bruno Torturra journalists and advisor of the foundation, and by the journalist Ivan Marsiglia. The magazine was created to celebrate the 10th anniversary of the foundation.

"They would form the best writing team in the country if they worked together", said Torturra on the team gathered around this publication.

For him, the type of storytelling used in the magazine is an interesting way of promoting the importance of human rights, an expression that has been badly beaten in recent times.

The journalists invited were Andrea Dip, Bruno Paes Manso, Djamila Ribeiro, Flávia Oliveira, Fred Melo Paiva, Karla Monteiro, Leonardo Sakamoto, Lucas Ferraz, Ronaldo Bressane and Spensy Pimentel.

They wrote about partnerships that made possible actions such as fighting slavery; supporting LGBT groups; connecting mothers who lost children to violence; the search for paternity acnkowedgment; the protagonism of black women, men and young people; the fight for Indigenous rights; and the fight against the losses caused by major infrastructure projects and mega-events.

The magazine also carried articles signed by Ana Valéria Araújo, the Fund's executive director executive coordinator of Brazil Fund; and by Jorge Eduardo Durão, the foundation's president.

The themes that are part of the publication were discussed between journalists, counselors, former advisers and former counselors, as well as the staff of Brazil Fund.



The magazine A Brazil of Rights was launched in December, at the Centro Cultural Rio Verde, when we gathered the Fund's staff, advisors, board and partners to celebrate the ten years of the foundation. Music, nice conversations and an informal environment marked the celebration.




### **REINFORCING TRANSPARENCY**



With a modern graphic design and an index organization that facilitates the search for information, the **new Brazil Fund website** was released in 2016, marking the 10th anniversary of the Fund.

The available filters provide transparency to more than 300 projects, which were supported over a decade. The search engine allows you to search by topic, funding lines, regions, states, year and status (closed or in progress).

The disclosure of the activity reports, financial statements, titles and certificates, publications and newsletters and information on the Fund's supporters also followed the transparency principle adopted since the Fund's early years.

In addition, the website is supplied weekly with news related to the Fund's institutional performance and the activities carried out by the supported projects.

### INNOVATING IN DIGITAL COMMUNICATION



Videos, gifs and illustrations were some of the resources used by Brazil Fund in social media to promote its work throughout the year 2016. Content production was intense, both for the site and for social media - Facebook and Twitter.

Special attention was given to the promotion of series such as the # Say Yes to Human Rights, which carried video-testimonies of human rights defenders supported by Brazil Fund; to the series showing the story behind the Mothers of May Movement, which also completed 10 years in 2016; and to the series in which counselors and coordinators of the Fund made statements against the culture of rape in Brazil.



### PROMOTING HUMAN RIGHTS CONTENT

A partnership between The Huffington Post, a blog aggregator, made possible the publication of articles signed by the Brazil Fund on their website.

The articles discussed the importance of mobilizing society around human rights and on communication as an instrument of transformation. One of the texts shared the story of Margarida Genevois, one of the founders of the foundation and companion in many struggles of Dom Paulo Evaristo Arns, who died in 2016.

The partnership between the Fund and TVT, a TV Channel related with the Steelworkers and Bank Trade Unions. The channel broadcasted a series of videos on human rights produced by Brazil Fund.

### **Open Democracy**

Another important space used by the Fund in 2016 was the Open Democracy webiste. The executive directors of Brazil Fund, Ana Valéria Araújo and Maíra Junqueira, listed logistical issues and the lack of knowledge among Brazilians as obstacles to fundraising for human rights in the country.

Despite these obstacles, they stated that there are many people interested in supporting the development of a better country, and this is what makes possible the mobilization in defense of human rights.

In the text, they say that it will be easier to gain the support of society when Brazilians understand the importance of the groups that work in the front line defending rights and coping with violations.

### DISCUSSING STRATEGIC COMMUNICATION

In June, Ana Valéria Araújo, executive director of Brazil Fund, was the mediator of the "Is there a future for nonprofit organizations in Brazil?" at the 11th Abraji International Congress of Investigative Journalism.

The debaters were the journalists Leonardo Sakamoto and Bruno Torturra, who is also one of the advisors to Brazil Fund.

The initiative is part of the foundation's efforts to establish a dialogue with the media on the need to engage society in human rights-related causes.

### ComNet 2016

Alongside representatives of other Brazilian organizations, Maíra Junqueira, deputy executive director and development and institutional relations manager of Brazil Fund participated in ComNet 2016, an annual conference to discuss communication strategies for the social sector held in Detroit (USA) in September.

Five hundred social sector professionals from various countries discussed and exchanged experiences on the potential of communication and on strategies that can be used in this field.

Topics such as digital experiences of strategic communication, ways of influencing the audiences, the importance of understanding the message and of getting to know each target audience.
